Cooked Chickpeas, blended with Sweet Potato, Sunflower Seeds, Lemon Zest and spicy seasonings, then formed into a ball shape, dusted with flour, coated with batter and breadcrumbs before par-frying in Canola Oil. Product is then frozen and intended to be heated before consumption. Packed in 3 x 1kg bags per cardboard carton.

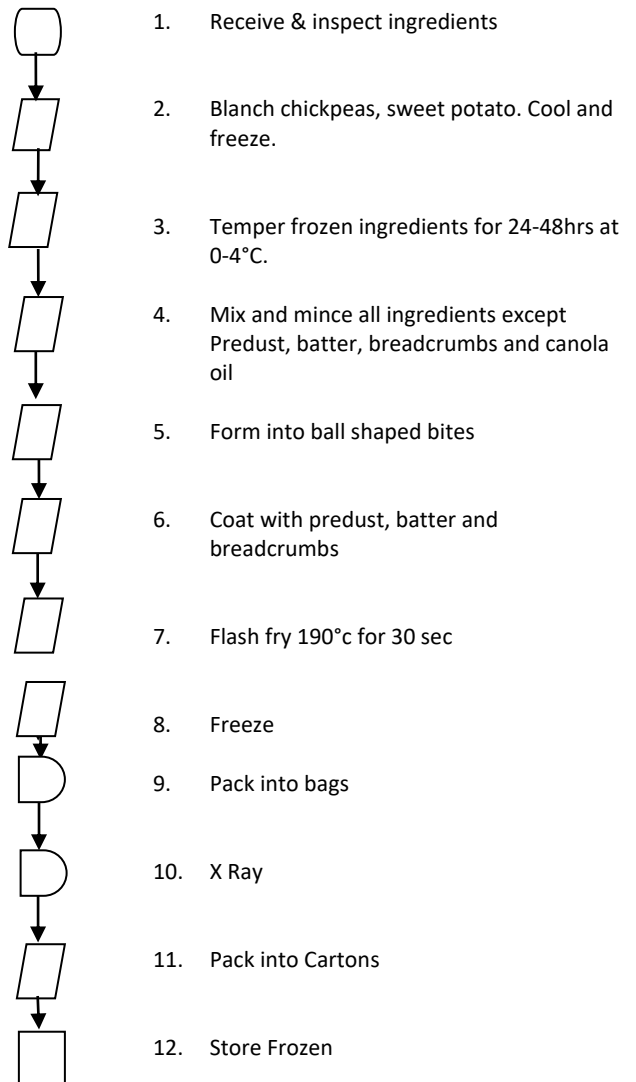
